CLASSES OFFERED—TENTATIVE CLASS ORDER

- First run no earlier than 8:00 a.m. each day.
- Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. The exhibitor is responsible for entering the dog in the correct class and height division. Dogs running in a lower height division than they are eligible for will be eliminated.
- Effective January 1, 2022, For Exhibition Only (FEO) and Fix and Go are permanent components of the AKC agility program. **We will offer For Exhibition Only (FEO) in ALL CLASSES at this trial, following AKC recommendations effective July 1, 2024.**
 - For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.
 - FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
 - Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
 - Dogs may be entered at any level (Novice, Open Excellent or Masters) in FAST, JWW, Standard or Premier classes. If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
 - The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.
 - Course time for FEO in Time 2 Beat, JWW, Standard, Premier and ISC will be 45 seconds. FAST courses times for each class/height are as noted in the Regulations.

ENTRY INFORMATION All entries received before the opening date specified on the first page of this premium will be returned. Paper entries received within the first 24 hours must include postage or be metered. Entries must be delivered by multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS, and DHL. Envelopes containing entries for more than the ten-dog maximum will be treated as an invalid entry and will be returned to the sender. No entries will be accepted by phone or fax. Express mail entries must include a signature waiver allowing them to be left at the secretary’s address. Returned checks do not constitute a valid entry fee. The Trial Secretary will add a \$25 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a cash-only basis for future entries.

LRDTC IS ACCEPTING ONLINE ENTRIES THROUGH www.labtestedonline.com. During the first 48 hours after opening, the initial limit of entries will be designated as follows: online entries: 30% (105), paper entries 70% (245), 350 runs per day. If either form of entry has not filled within 48 hours, the club reserves the right to decrease or increase these limits accordingly.

Wait List LRDTC is offering a wait list to fill openings created by withdrawn entries after the trial’s closing date/time. A maximum of 20 entries will be placed on the club's waitlist. All entries, including wait-listed entries, must be received by the Trial Secretary prior to the trial closing date listed on the front of this premium. Any entries withdrawn with notice of withdrawal received by the Trial Secretary by 6:00 p.m. CST on the Sunday prior to the first day of the trial will be replaced by a wait-listed entry if any are available. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait list into the trial by 6:00 p.m. CST on the Sunday prior to the first day of the trial will receive a full refund.

Refund Policies Entry fees will be refunded if an entry is withdrawn before the closing date and time. Entry fees will not be refunded if a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. Entry fee will be refunded in full for bitches in season. Entry fee less the AKC recording fee will be refunded for injured dogs. The Trial Secretary must receive written notification of a claim for refund by letter hand delivered, emailed, or postmarked at least thirty (30) minutes before the trial begins. No entry fees will be refunded if the trials cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other causes beyond the control of the club, trial committee, or trial secretary.

Important withdrawal information If you wish to withdraw your dog prior to closing, all requests **MUST BE MADE IN WRITING AND CONFIRMED BY THE TRIAL SECRETARY**. If you do not receive a confirmation from the Trial Secretary, your dog has not been withdrawn.

ELIGIBILITY This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club, or have an AKC Limited Registration, or are of a registrable breed that have obtained a PAL or ILP number from AKC, or have an AKC Canine Partners listing number, except bitches in season, aggressive dogs, blind dogs, or dogs suffering from deformity, injury, or illness which may affect the dog's physical or mental performance.

JUMP HEIGHT CARDS and MEASURING A copy of the dog's jump height card is not required to be submitted with your entry. However, you must present the official card at the trial on request.

As of March 1, 2021, if a VMO or Agility Field Representative is measuring dogs at a trial, all present and entered dogs without a valid measurement must be measured prior to running. When filling out the entry form, there is a section on the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the Dogs to Be Measured List.

MOVE UPS Dogs may be moved up to a higher class at the request of the owner, because of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary no later than 6:00 p.m. CST on the Monday preceding the start date listed on the front of this premium. Daily move ups during the trial are allowed provided that the request is received in writing by the Trial Secretary within half an hour of the last run of each day.

WALK-THRUS Handlers in all classes are permitted to walk the course without a dog during the walk-through period held prior to the start of each class. The course walk-through is restricted to handlers entered in that class only and will be split as needed to minimize the number of handlers in each walk-through group. Further details will be in the final confirmation. A warm-up area, consisting of a regulation agility jump, will be provided.

AWARDS Rosettes for 1st place teams in each jump height in each class, including T2B. Strip ribbons will be awarded to 2nd through 4th place teams in each jump height in each class. Dogs must qualify to receive rosettes or ribbons. QQ ribbons will be available for dogs earning a Q in Master STD and JWW on the same day; QQQ ribbons for Master STD, JWW, and FAST on the same day. Qualifying ribbons will be awarded to all dogs receiving qualifying scores. Titling rosettes will be awarded for each titling dog. There are AGCH/MACH/PACH/PAX bars and ribbons for dogs earning those titles. **WE HAVE NEW ROSETTES!**

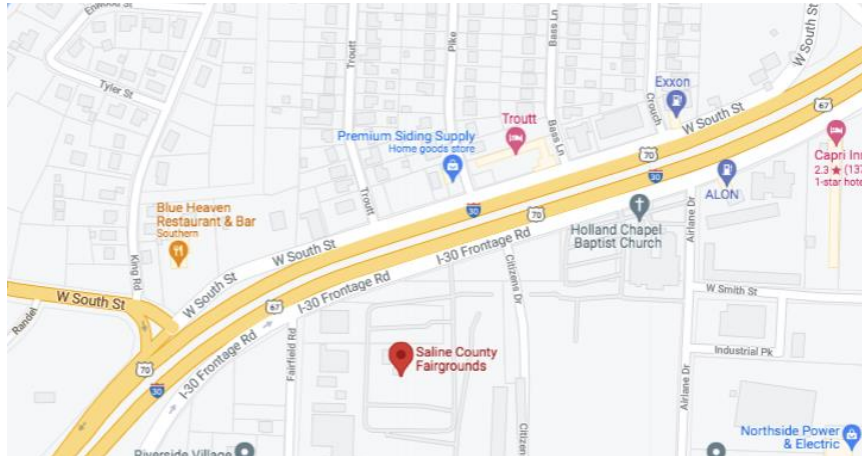
RV parking is available at the Saline County Fairgrounds for a cost of **\$25/night**.

DIRECTIONS TO TRIAL SITE

From the east Take I-30 exit 116 toward Sevier St./ South St. After you pass under the overpass, turn right to cross back over I-30. Take first right turn past the overpass then turn left onto the I-30 frontage road then left into the Saline County Fairgrounds. The turn-in for the Fairgrounds is past the entrance for Riverside Park.

From the west Take I-30 exit 116 toward Sevier St. Turn left onto the I-30 Frontage Rd. Continue east to the Fairgrounds on the right.



ADDITIONAL INFORMATION FOR EXHIBITORS

-  The safety of dogs and exhibitors is a primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and their dogs are familiar with and able to perform all obstacles safely.
-  The Little Rock Dog Training Club (LRDTC), its officers and Board members, Agility Trial Chair and Committee, the Trial Secretary, and their agents, assume no responsibility for any loss, damage, or injury sustained by the exhibitors of their dogs or property. YOU are responsible for any damage you or your dog(s) cause at the trial site. The Trial Committee will be convened for cause. The trial site is a covered horse arena which is partially open on the sides. It is impossible to totally secure the area at night. Please do not leave valuable items at the trial site at night. Neither the Saline County Fairgrounds Arena Committee nor the LRDTC will be responsible for property left overnight at the trial site. No dogs can be left in the arena overnight.
-  You are responsible for any damage you or your dog(s) cause at the trial and/or hotel/motel grounds. Help us continue to offer you a wide selection of places to stay by cleaning up after your dog and ensuring that you, as a responsible dog owner, and your dogs are always welcomed.
-  It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees will be made.
-  All dogs must be on leash at all times or otherwise confined when on trial site except when in the designated warm-up area or competing on the course.
-  Exhibitors are responsible for cleaning up after their dogs. Any exhibitor failing to do so may be excused without a refund of entry fees if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the trial site.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
