- Dogs will be run small to tall all 3 days.
- A and B classes will be combined. The Preferred classes will run in conjunction with the regular classes.
- Standard, T2B, and JWW will run all three days. FAST will run on Friday only.
- Probable sequence is T2B, Excellent/Masters JWW, Excellent/Masters STD, Open JWW, Open STD, Novice JWW, and Novice STD all three days; FAST will be first on Friday. This is subject to change by the judge.

Dogs Eligible to Enter

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club, or have an AKC limited registration, or are of a registrable breed that have obtained a PAL or ILP number from AKC, except bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. This event is accepting entries for dogs listed in the AKC Canine Partners Program.

Moving Up To The Next Class

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that request is received by Monday, October 30, 2017, at 5 p.m. CDT. Move-ups over the Weekend will be accommodated provided the information is provided before the trial ends on Friday or Saturday.

Prizes & Awards

Rosettes for 1st place teams in each jump height in each class. Strip ribbons will be awarded to the 2nd through 4th teams in each jump height in each class. Dogs must qualify to receive Rosettes or ribbons. Qualifying ribbons will be awarded to all dogs receiving qualifying scores. Titling Rosettes will be awarded for each titling dog. There are MACH/PACH/PAX bars and ribbons for dogs earning their MACH/PACH/PAX.

Warm-Ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. The walk-through period allows handlers to plan their strategy running the course and will be held prior to each class, following the judge's briefing. A warm-up area, consisting of a regulation agility jump, shall be provided.

Jump Height Cards

Jump height cards are no longer required to be submitted with the entry form. The entry form has been changed to indicate whether the dog has been issued a temporary or permanent height card, or needs to be measured. If the dog needs to be measured, it is the exhibitor's responsibility to ensure that the box on the entry form is checked, and that the dog is measured prior to running by the Judge of Record. This measurement will be valid for that weekend of trials only. Judge Pinneri is not a VMO and will not be able to provide an official measurement.

Important Withdrawal Information

If you wish to withdraw your dog prior to closing, all requests **MUST BE MADE IN WRITING AND CONFIRMED**. Please email the trial secretary. If you do not receive a confirmation back, your dog has **NOT BEEN** withdrawn.

Notice to Exhibitors:

*The safety of the dogs is our primary concern. By entering this Show, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Show Committee.

*No entry will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond the control of the organizing committee.

*It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of any fees will be made.

*Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries cannot be entered into the show. All entries must be made on Official AKC Entry Forms or copies and **must include the Agreement and Rules**. No Entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

*Handlers may opt to run in a higher height division for regular classes, but not in a division lower than their proper height division. In the Preferred classes, dogs may only be entered in their proper jump height division.

***Bitches in season and injured dogs** are not permitted to compete in Agility Show. **Entry fee will be refunded in full for bitches in season. Entry fee less the AKC recording fee will be refunded for injured dogs.** The Trial Secretary must receive written notification of such a claim for refund by letter hand delivered, emailed or postmarked at least thirty (30) minutes before the trial commences.

*All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. **Judges are not required to wait for dogs.** The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.

*Exhibitors are responsible for cleaning up after their own dogs. **Please** help us keep this site clean for future use.

*Returned checks do not constitute a valid entry fee. The Show Secretary will add a \$25 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.

*The Little Rock Dog Training Club, its officers and Board members, the Show Secretary, their agents, etc. assume no responsibility for any loss, damage, or injury sustained by the exhibitors of their dogs or property.

***YOU** are responsible for any damage you or your dog(s) cause at the show site. Event Committee will be convened for cause.

*The Show site will be available to exhibitors after 4:00 p.m. on Thursday November 2, 2017, and 7 a.m. Friday through Sunday.

***YOU** are responsible for any damage you or your dog(s) cause at the show and/or hotel/motel grounds. AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS: Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners** SM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner? _____
