- Dogs will be run low to high all 3 days.
- A and B classes will be combined. The Preferred classes will run in conjunction with the regular classes.
- Standard, T2B, and JWW will run all three days. FAST will run on Friday only.
- Probable sequence is T2B, Excellent/Masters JWW, Excellent/Masters STD, Open JWW, Open STD, Novice JWW, and Novice STD all three days; FAST will be first on Friday. This is subject to change by the judge.

### **Dogs Eligible to Enter**

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club, or have an AKC limited registration, or are of a registrable breed that have obtained a PAL or ILP number from AKC, except bitches in season, aggressive dogs or blind dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. This event is accepting entries for dogs listed in the AKC Canine Partners Program.

### **Moving Up To The Next Class**

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that request is received by Monday, April 24, 2017, at 5 PM CDT. Move-ups over the Weekend will be accommodated provided the information is provided before the trial ends on Friday or Saturday.

#### **Prizes & Awards**

Rosettes for 1st place teams in each jump height in each class. Strip ribbons will be awarded to the 2nd through 4th teams in each jump height in each class. Dogs must qualify to receive Rosettes or ribbons. Qualifying ribbons will be awarded to all dogs receiving qualifying scores. Titling Rosettes will be awarded for each titling dog. There are MACH/PACH/PAX bars and ribbons for dogs earning their MACH/PACH/PAX.

#### Warm-Ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. The walk-through period allows handlers to plan their strategy running the course and will be held prior to each class, following the judge's briefing. A warm-up area, consisting of a regulation agility jump, shall be provided.

### **Jump Height Cards**

Jump height cards are no longer required to be submitted with the entry form. The entry form has been changed to indicate whether the dog has been issued a temporary or permanent height card, or needs to be measured. If the dog needs to be measured, it is the handler's responsibility to ensure that the box on the entry form is checked, and that the dog is measured prior to running. Judge Syner is NOT A VMO.




Diamond TR Ranch is located west of Little Rock on Highway 10 (Cantrell Road leaving Little Rock).
